In consideration of being allowed to participate in any way in the SKATEPARK program for: THE **FLOW ALTERNATIVE SPORT PARK, LTD.**, herein known as SKATEPARK, related events, activities and all other sanctioned parks and events the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury to me does exist, and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If I observe any unusual significant concern in my readiness for participation and/or in the program itself, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE **THE FLOW ALTERNATIVE SPORT PARK, LTD.**, its officers, officials, agents and/or employees, other participants, sanctioned events, sanctioned parks, sanctioned organizations, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I, for myself and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent of the law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT AND INDUCEMENT. ## **SKATEPARK REGULATIONS**

***Failure to comply with these rules can result  
in immediate ejection from the park.***

1. Only one rider is permitted on a ramp at any given time.
2. All participants must wear a helmet at all times. In-line skaters must wear wrist guards at all times. Knee and elbow pads are strongly recommended.
3. Bicycles must have working brake.
4. A completed release form and picture ID or membership card are required to enter the park.
5. Participant must possess the basic, necessary skills to ride safely and under control at all times.
6. Sufficient time must be allowed for a participant to use a ramp and clear the area before the next participant begins. If a rider falls, an indefinite amount of time should be allowed until the ramp and path is clear.
7. Participant must always check all paths leading to and from an obstacle prior to attempting. Many ramps can be ridden in more than one direction and/or angle.
8. Participants should never sit, stand or loiter on or near a ramp for this greatly increases the likelihood of a collision.
9. Spectators should never enter the ramp/obstacle area of the park for any reason.
10. Absolutely no food or drink is allowed into the skating area. Food and drink should not leave the break area.
11. Participants should always check the condition of their gear to make sure it is in safe working order. The Flow is not responsible for the condition of equipment that participants use or any injuries that may result from failure of that equipment.
12. Absolutely no smoking, alcohol, drugs, fighting, loitering, tagging or vandalism will be tolerated. There is to be no loitering outside of the park (outside of front doors, parking lot, around building, etc.) due to lease restrictions. Please help us keep our skatepark open!
13. Management reserves the right to eject anyone from the park at any time for any reason.
14. No refunds.

Although the park is monitored by the attendant, it is impossible to monitor the flow, traffic and behavior of all participants at all times. The ultimate responsibility for the smooth flow of bicycles, skateboards and in-line skates relies on strict adherence to the above rules by all participants. Separate areas for bicycles, skateboards and in-line skates are not provided. Violation of these rules should be immediately reported to the attendant at the front desk. Anyone caught violating these rules will be ejected from the park.

I have read these rules and agree to abide by them unconditionally. If my child is under the age of 18, I have thoroughly explained the rules to my child and accept the terms and conditions under which the park operates.
